A BRIEF STATEMENT OF FAITH FOR LANAKILA BAPTIST SCHOOLS

8. I understand that if my child is expelled from school, there is no refund of tuition or fees.
9. Tuition is due on the selected date on the MAP agreement. The school will allow a 5 day grace period before assessing a \$5 late payment fee, every day the tuition is NOT paid.
10. **Withdrawal from school** requires **4 weeks advanced written notice** of the planned withdrawal. Tuition will be due for the 4-week's notice period regardless of whether the student attends school. Tuition will not be prorated for partial months of enrollment, full month will be due. Paid in full account refunds are subject to a \$30 processing fee and void of the 5% discount.
11. I understand that there is a **\$50.00 NSF fee** for all **returned checks or MAP payments**.
